VETERANS FIRST: PROVIDES SHORT-TERM, INTENSIVE CASE MANAGEMENT AND RENTAL ASSISTANCE TO HELP HOMELESS VETERANS AND THEIR FAMILIES GET BACK INTO HOUSING QUICKLY AND TO PREVENT HOMELESSNESS FOR VETERAN HOUSEHOLDS AT RISK OF EVICTION. THE PROGRAM TARGETS EXTREMELY LOW-INCOME HOUSEHOLDS (LESS THAN 30 PERCENT OF THE AREA MEDIAN INCOME) AND SERVES THE DISTRICT OF COLUMBIA AND EIGHT SURROUNDING COUNTIES IN MARYLAND AND VIRGINIA. DURING THE YEAR ENDED SEPTEMBER 30, 2016, 567 HOUSEHOLDS WERE SERVED (ENCOMPASSING 779 INDIVIDUALS); OF THOSE WHO EXITED THE PROGRAM DURING THE YEAR, 88 PERCENT GRADUATED TO STABLE PERMANENT HOUSING.
